Dear Sir/Madam,

We write to express our deep concern regarding the conduct of the tenant(s) residing in the apartment you are leasing in our building. As administrators, we have received numerous complaints from other residents about the tenant(s) exhibiting disruptive behaviour, causing distress to their fellow neighbours.

It has come to our attention that there have been reports of excessive noise emanating from your apartment, particularly late into the night, with loud parties being a recurring issue. It is imperative to respect the rights of other tenants to live in a peaceful and quiet environment, and we kindly request that you ensure this behaviour is ceased immediately.

We have also noticed a concerning build-up of refuse outside your apartment, which is attracting vermin and causing unpleasant odours. It is your responsibility to ensure that your tenant(s) dispose of their waste in the appropriate manner and adhere to the building's policies on waste disposal.

Furthermore, we have received multiple complaints about inappropriate behaviour in the communal areas of the building, such as smoking, that make other tenants feel uncomfortable and unsafe. We request that you remind your tenant(s) of the need to respect their fellow residents and follow all building regulations.

We hope that you will take the necessary steps to address these issues and ensure that your tenant(s) are respectful towards their neighbours in the building. Failure to comply with building regulations and to maintain a peaceful and harmonious living environment may result in legal action being taken.

Penalty Measures for Nuisance Neighbours

I. Excessive noise:

- a) First offence: The responsible tenant will be notified of the disturbances and reminded of the community rules. Follow-up will be conducted to assess whether there is an improvement in their behaviour.
- b) Second offence: A written warning will be issued, stating the future consequences if the non-compliance persists. In extreme cases, intervention from relevant authorities may be requested.
- c) Third offence: Economic sanctions will be imposed in accordance with the internal regulations of the community. The fine for this offence is £100, and legal actions may be taken if necessary.

II. Non-compliance with waste disposal:

- a) First offence: The responsible tenant will be notified and reminded of the established schedule and procedures for rubbish collection. A deadline will be given to correct the behaviour.
- b) Second offence: A written warning will be issued, outlining additional consequences in case of repeated non-compliance.
- c) Third offence: Economic sanctions will be imposed. The fine for this offence is £50, and additional measures such as temporary suspension of access to community services may be implemented until the issue is resolved.

III. Uncivil behaviour in common areas:

- a) First offence: The responsible tenant will be notified and required to immediately cease the uncivil conduct. The rules of behaviour in common areas will be reiterated.
- b) Second offence: A written warning will be issued, indicating the future consequences if the inappropriate behaviour persists.
- c) Third offence: Economic sanctions will be imposed. The fine for this offence is £75, and additional measures such as temporary suspension of certain privileges or community services may be taken.

These penalty measures are designed to ensure the well-being and peaceful coexistence of all residents in the neighbourhood community. It is expected that tenants respect the rules and commit to maintaining a harmonious environment for the benefit of all.
